Setting Our Course For The Next Three Years

CCB set the course for the next three years through a Strategic Planning process this year, with input from our Board of Directors, staff, families and community leaders. CCB remains focused on our mission – to Strengthen Families Through High Quality Child Care, Education, Support Services and Advocacy. In the next three years, we will focus on the following goals to support this mission:

- recruit, develop and retain a highly qualified, well-trained and diverse workforce
- foster community awareness of the many different family support and child care programs CCB provides
- address changing community needs by expanding and/or enhancing our programs and services
- increase discretionary income to strengthen programming, invest in capital improvements, and secure long-term financial stability
- engage in advocacy efforts to support funding, policy and systems for inclusive high-quality child care and family support services
- ensure a representative board who are passionate, invested, and equipped to support and sustain the agency

More Educators, More Care

Child Care of the Berkshires identified a need for more child care options in Berkshire County, particularly in Pittsfield. In response, the agency partnered with the City of Pittsfield, utilizing American Rescue Plan Act funds to recruit and support new family child care providers. Family child care providers care for and educate children in their homes, offering a small group experience, allowing siblings to be together and providing care in neighborhoods close to families. CCB offered resources, supplies, and incentives to individuals interested in offering early education in their homes. Kara Daoust, CCB's outreach specialist and coach, guided potential providers through the process, helping them set up their homes, navigate the licensing process, and complete necessary trainings. As a result, four new homes were opened in FY 2024, serving up to 24 children, with additional providers opening soon.



25 YEARS OF STRENGTHENING FAMILIES



This year, CCB's Family Center program celebrated 25 years of supporting and strengthening families. Originally launched as Family Net in 1999, the program has grown significantly over the years. What began as a focus on playgroups has since expanded to include the ParentChild+ early literacy home visiting program, a children's clothing and book exchange, parent education workshops, connections to community resources, free diaper distribution, family events including Ooey Gooey Nights, STEAM time and Touch a Truck, storywalks, and other initiatives designed to empower families as their children's first teachers and to enhance school readiness.

TEAMING UP FOR SUCCESS

Child Care of the Berkshires is happy to be working closely with the North Adams Public Schools and Hoosac Valley Regional School District to provide 3 and 4 year-olds with equitable access to high quality preschool programming, while ensuring families have multiple provider options to choose from across public and community-based classrooms. Through Commonwealth Preschool Partnership Initiative (CPPI) Grants, we are working to level the playing field for kindergarten readiness, establishing coordinated curriculum and similar goals regardless of where a child is enrolled. We do this through shared professional development, curriculum and collaboration.



VALUING THE STAFF AS THE HEART OF WHAT WE DO

CCB recognizes that our caring, hard working and dedicated staff are vital to our mission. This year we are proud to have increased staff wages, given staff bonuses, provided opportunities for fun and learning together, supported staff in earning college degrees, sent staff to national and local conferences and helped staff pay for their own child care.


Family Child Care System

22,865 diapers distributed


Parenting Partnership
